

NOTE: ALL TIMES IN MDT (UTC-6)

Seo arrived at Janus' House no later than 1:36 PM on April 21st, 2024 (Point 2), and no earlier than 12:48 PM the same day, as she ran into Sven at a TQ watchtower. (Point 1)

Hilja arrived alone at around 1:36. (Point 3) She explored for a while. The first item known to be taken was a netherite hoe removed from its chest by Hilja at 2:16 PM. (Point 4) This is proven by the advancement "Serious Dedication" requiring a netherite hoe to be obtained. We know the netherite hoe was from here, as it is stated explicitly. (Point 6) Seo acquires the same hoe 3 minutes later.

At 2:40 PM, both Seo and Hilja remove ancient debris from the chests. (Point 5) This is proven by the "In The Depths" advancement. It is remarked that it's odd they got this advancement after "Serious Dedication." (Point 5) It is explained away as trading with Aeternal for netherite at the time. (Point 5)

6 minutes later, at 2:46 PM, Seo announces that the hoe was from a pre-raid base. (Point 6) It can be deduced they knew it was pre-raid due to the presence of chorus fruits (Point 12) and End contraband. (wiki page) These items are only obtainable through having been transferred from Season 1.

The transfer of items began at least one hour before this announcement. (Wiki page) Seo "discovers" the treasure one minute after announcing the base. (Point 7) However, this is most likely for worldbuilding or to conceal the timeline, as, again, the wiki states the existence of the treasure specifically was kept secret "[for] the first couple of hours [...] while it was covertly transported to Pūnan Dáce." (Wiki page)

It was 6 days later, at 11:53 AM on April 27th, 2024, that any of the keywords "Janus," "JANVS," or altered capitalizations of the former 2 options come up in Discord search in relevant channels. (Point 8) It is thus the first public acknowledgement by Seo or Hilja that the house belongs to Janus.

On June 22nd, 2025, Fin asked Hilja directly if there were any indications of whose base it was, to which she said no, and that she only fully understood whose it was later, with help from Aeternal. (Point 9)

Therefore, we know that the items were removed as early as 2:16 PM (although most likely this began earlier, as there was only one netherite hoe, and they probably didn't start with that chest). They announced it publicly at 2:46 PM the same day, but only were fully aware of whose it was several days later. We do know the End items were confiscated by Aeternal, but this occurred at the UNG meeting 6 days after the theft. (Point 11) This means that there was no way that Hilja and Seo knew whose base it was when removing the items, only that it was pre-raid. This doesn't remotely constitute due diligence. They discovered extremely valuable items from an old base, and proceeded to do no known background checking to verify if the owner was

able to be contacted (as they didn't really know, by their own admission, who the owner was). Hilja also implied she wouldn't have asked anyways. (Point 10) Hilja and Seo took items from a base without asking. That is theft.

Also note that Hilja violated UNg law on mandates (Point 14) through repeated attempts to interfere in the mandate. (Point 13) This violates mandate law as she did not include any provisions for this in her will (Point 15), which would have been the only way to circumvent the mandate system as defined. (Point 14a)

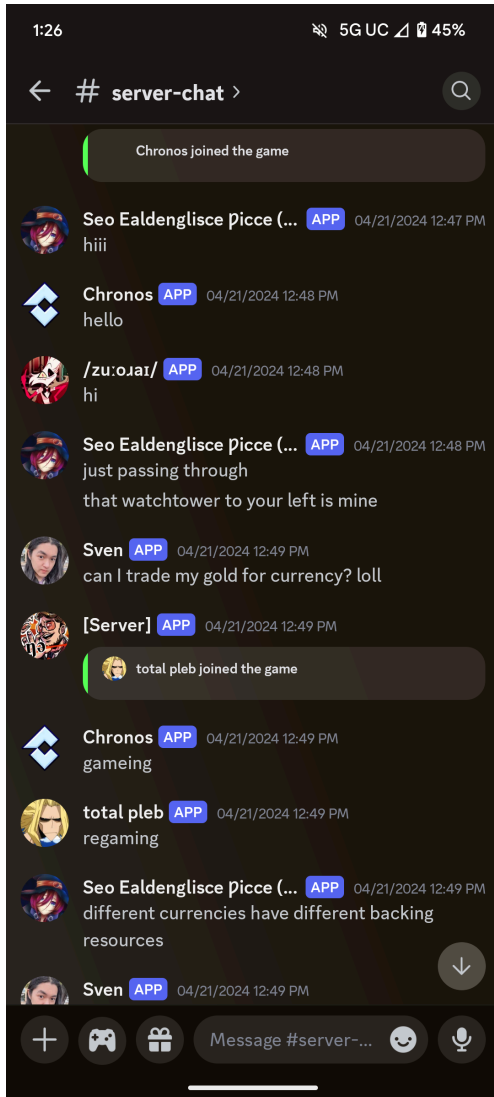
In conclusion, both Hilja and Seo violated server rules by stealing from Janus and attempting to conceal this theft by being vague and secretive, including lying about the origins of the stolen hoe. Hilja also most likely committed a violation of UNg law. There is also the problematic nature of the name "El Dorado," due to the colonial connotations and history of that name. All in all, there was theft, lying, colonialist ideals, and overstepping; there was no due diligence or respect. They broke the rules.

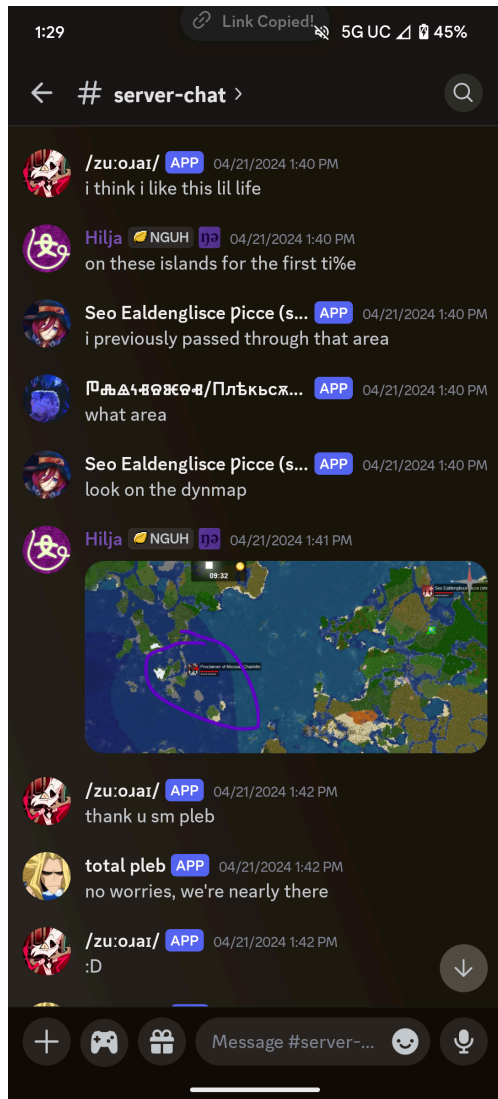

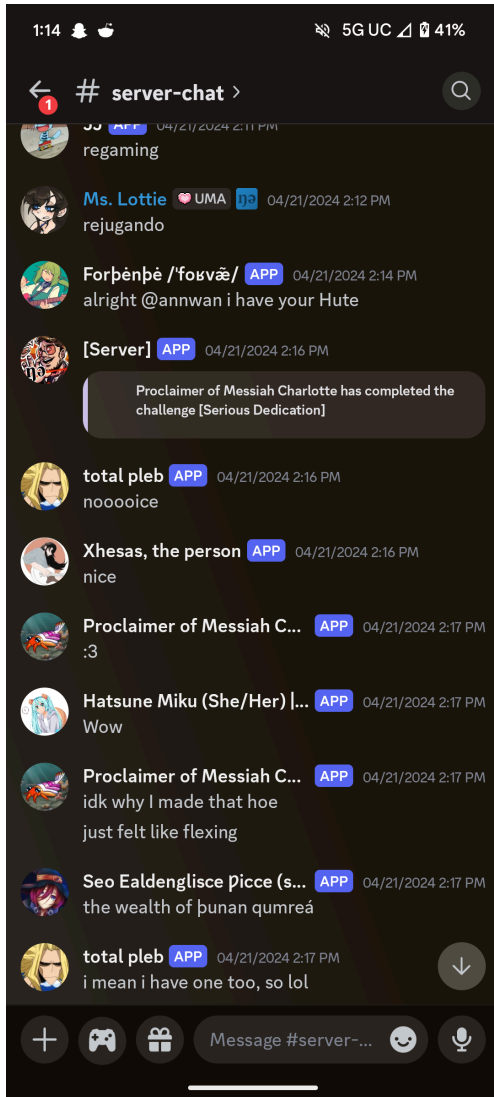

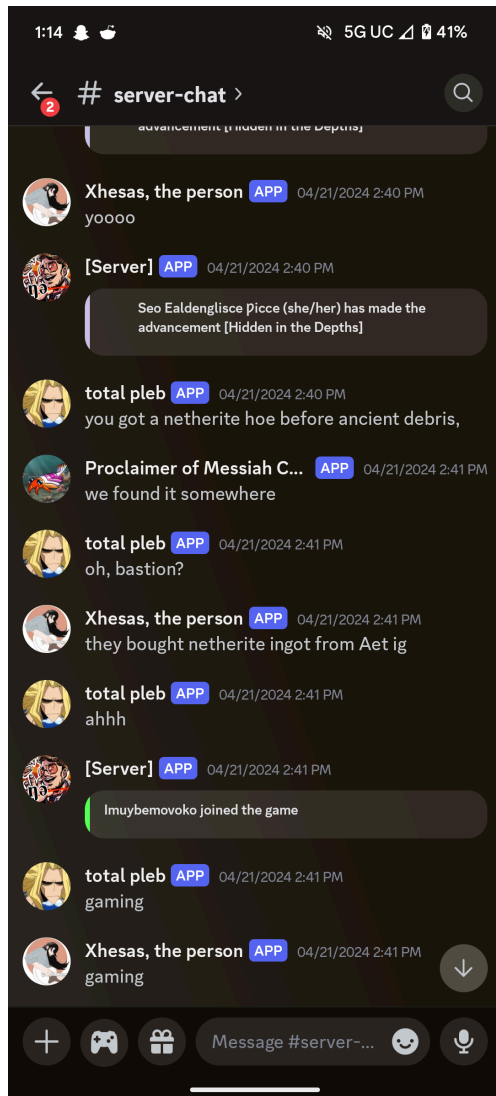
